LAST WEEK'S MEETING

Our guest speaker was John Murphy, the Federal Member for Lowe, whose subject was 'What it is like to be a Federal Member of Parliament' He was introduced by Bert Houston.

John was born in 1950 at Dunedoo and at the tender age of 10 became a border at Waverley College. At the age of 16 he was the golf champion of the school. His passion was music and he won a scholarship to the Conservatorium of Music, which he did not pursue. Instead he completed his schooling, joined the Public Service and served in the Department of Veteran Affairs for 28 years.

He was a councillor on Drummoyne Council from 1995 until elected to Parliament as the Member for Lowe in 1998, and has retained his seat at each election since then.

The responsibility of a local member is to serve for the benefit of all constituents in the electorate. 40% of people in the electorate were not born in Australia, so immigration is a major factor. He takes credit for the MRI unit installed at Concord Hospital and for the listing of Herceptin (for Breast Cancer) on the PBS, in conjunction with Professor David Gillette. As a local member he receives many invitations to attend meetings and other functions, often as guest speaker.

Some of the many privileges of being a member of parliament have included meeting the Queen, Prince Charles, the Governor General and many other World wide dignitaries.

As a politician John has no illusions about some of the problems facing Australia – Global warming, the Iraq War, the drought and the economy. Although he does not personally support the 'Stem cell' Bill currently being debated in the Lower House, he understands and appreciates the alternate view of many of his colleagues.

ROTARY INFORMATION

Constitution – Election of the Board

The constitution of The Rotary Club of Strathfield, Inc states that the Board is the governing body. The Board shall have general control over all officers and committees and, for good cause, may declare any office vacant.

The Board will consist of President, President Elect & Club Service Director, Community Service Director 1, Community Service Director 2, Vocational Service Director, International Service Director, and Youth Service Director. A Secretary, and a Treasurer will be appointed to serve on the Board, and Sergeant-at-Arms is also appointed and may be invited to serve on the Board.

At the Annual General Meeting on Wednesday 6 December 2006 a list of members who have accepted nomination to fill the six positions vacant on the Board in accordance with the constitution will be presented. If less than six nominations have been received, further nominations may be called from the members present, and included on the list subject to their acceptance.

Should the number of nominations exceed the number of Board members required, an election will be held. A ballot paper listing nominations in alphabetical order will be handed to all members present who will vote by deleting all but 6 names they prefer. Two scrutineers will be appointed to count the votes and pass a list of the six successful candidates to the President.

1) The President will declare the poll and name the six successful candidates who will join with the current president elect to form the Board which will take office on 1 July, 2007.

2) Nominations will then be called from the six newly elected members for election to the position of President Elect (President for year 2008-2009). Should more than one nomination be received and accepted by the nominees, a ballot to elect a successful candidate will be held.

3) The incoming Board will appoint a secretary and a treasurer who will automatically become members of that Board. A Sergeant-at-Arms will also be appointed who may or may not be named a member of the Board.
